

Official Contest Rules and Regulations

Atlantic Nationals Automotive Extravaganza Ltd.'s 26th Annual Atlantic Nationals Automotive Extravaganza Random Prize Draw (the "**Contest**")

- (1) **Sponsors.** The Contest is presented by Atlantic Nationals Automotive Extravaganza Ltd. (the "**Contest Organizer**"), in partnership with Mothers Polishes Waxes Cleaners, Canadian Tire, Action Car and Truck Accessories, the City of Moncton, and Canadian Tire ("the "**Show Partners**"), and hosted by Atlantic Nationals Committee and the City of Moncton (the "**Contest Hosts**"), and sponsored by the following entities (the "**Contest Sponsors**"):

 - (c) **Contributing Sponsors:** Kwik Wire, Dakota Digital, Lokar Performance Products Inc., Vintage Air Inc., Borgeson Universal Company, Diamond Back Classic Tires, and Ididit Inc.
- (2) **Eligibility.** The Contest is open to all legal residents of Canada who have reached the age of majority in the province or territory in which they reside.
 - (a) There are three (3) categories of prizes available to be won (the "**Contest Prizes**"): the Grand Prizes, the Attendance Prizes, and the Daily Prizes.
 - (b) Eligible entrants for the Grand Prizes and Daily Prizes are registered participants of the 2026 Atlantic Nationals Automotive Extravaganza (the "**Event**") who have registered a vehicle for the entire Contest Period and have a legitimate title, or legitimate right of possession, to the vehicle they have registered for the Event. Single day registrations are not eligible for either the Grand Prize or Daily Prize draws.
 - (c) Eligible entrants for the Attendance Prizes are all those who are eligible for the Grand Prize, as well as all spectators in attendance at the Event, who fulfill the entry requirements below.

- (d) Committee members of the Contest Organizer, or a member of any such committee member's immediate family (regardless of where they live) or a person with whom any such person is domiciled (whether related to the employee or not) are not eligible to enter the Contest. In these Official Contest Rules and Regulations, the words "immediate family" include a partner or spouse. By participating in this Contest, entrants acknowledge compliance with, and agree to be bound by, these Contest Rules. Entrants who do not comply with any of the Contest Rules are subject to disqualification by the Contest Organizer, in the Contest Organizer's sole discretion.
- (3) **Contest Dates and Times.** The Contest begins on July 15, 2026, at 12:30:00 p.m. ADT (UTC -3) and ends on July 19, 2026, at 02:59:59 p.m. ADT (UTC -3) ("**Contest End Date**") after which time the Contest will be closed and no further entries will be accepted (the "**Contest Period**").
- (4) **How to Enter.** Entrants can enter by registering a vehicle for the Event for the entire Contest Period and having a legitimate title, or legitimate right of possession, to the vehicle they have registered for the Event.
- (a) Each eligible entrant for the Grand Prize is allotted one (1) ballot for every vehicle they have registered in the event for the entire Contest Period.
 - (b) The Contest Organizer, Show Partners, Contest Hosts, and Contest Sponsors will not be responsible for late, delayed, misdirected, or lost entries.
 - (c) Prior to July 12, 2026, entrants may register by electronic registration through the Contest Organizer's website (<http://www.atlanticnationals.com>) at a cost of:
 - (i) \$50.00 for registration prior to January 15, 2026; or
 - (ii) \$60.00 for registration between January 16, 2026, and July 12, 2026.
 - (d) Paper based on-site registration will also be available on July 18 and July 19, 2026, at a price of \$70.
 - (e) For this Contest, receipt of an internet entry occurs when the Contest Organizer's server records the entry information.
 - (f) All entries must be complete and are subject to verification by the Contest Organizer, in its sole discretion.
 - (g) Any attempt or suspected attempt to use robotic, automatic, programmed or otherwise illicit means to enter the Contest, or any other methods not authorized by these Contest Rules, for example, but not limited to, creating multiple accounts, identities, or registrations, all in the Contest Organizer's sole discretion, shall be deemed as tampering and may disqualify you from entering, participating and/or winning a prize. Entries that contain false or incomplete information are void. Entries that are late, lost, stolen, illegible, contain false information, are damaged, misdirected, mutilated, garbled or incomplete, altered or otherwise irregular or that do not conform with or satisfy any or all of the conditions of the Contest Rules are void. Entrants grant Contest Organizer a non-exclusive license to use all entries for any purpose. No correspondence will be entered into except with Selected Entrants,

as defined below. Proof of transmission (for example, screenshots or captures) does not constitute proof of entry or receipt of an entry.

(5) **Contest Prizes.**

- (a) There are a total of twenty-three (23) **Contest Prizes** to be won, consisting of twenty-one (21) **Grand Prizes**, two (2) **Attendance Prizes**, and an unknown number of **Daily Prizes**.
- (b) The twenty-one (21) Grand Prizes consist of three (3) **Show Prizes**, fourteen (14) **Sponsor Prizes**, and four (4) **Cash Prizes**.
- (c) The three (3) **Show Prizes** are as follows:

- (d) The fourteen (14) **Sponsor Prizes** are as follows:
 - (i) One (1) gift certificate from Action Car and Truck Accessories, with a total estimated of \$1,000.00 CAD (One Thousand Canadian Dollars).
 - (ii) A Miller Prize Package from Miller Welding, which includes:

 - (C) One (1) Miller Digital Elite Welding Shield #296768, Vintage Roadster Clearlight x4, with a total estimated value of \$549.00 CAD (Five Hundred Forty-Nine Canadian Dollars).
 - (iii) Four (4) separate Canadian Tire Prize Packages:
 - (A) From Canadian Tire Dieppe, one (1) “Frozen Treats Package” including: one (1) Ninja SLUSHi XL Slushie Machine, one (1) Slush Puppy Base, one (1) Slush Puppy Flavor Grape, one (1) Slush Puppy Flavor Shocker, one (1) Slush Puppy Bottle Distributor, one (1) Ninja CREAMi Ice Cream machine, and one (1) Ninja Creami Pints, with a total estimated value of \$1,035.00 CAD (One Thousand Thirty-Five Canadian Dollars);
 - (B) From Canadian Tire Moncton, one (1) “Mechanic Package”, including: one (1) Maximum 15G Quiet Air Compressor, one (1) Maximum Impact Wrench, one (1) Maximum Impact Socket Set, one (1) Maximum 50 Foot Air Hose, one (1) Maximum 25pc Air Tool Accessory Pack, and

one (1) Mastercraft Inflation Gun, with a total estimated value of \$1,010.00 CAD (One Thousand Ten Canadian Dollars);

- (C) From Canadian Tire Riverview, one (1) “Grill Package”, including: one (1) Blackstone 36inch Griddle, one (1) Blackstone Griddle Cover, one (1) Meater Pro Wifi Meat Thermometer, one (1) Blackstone Griddle Tool Kit, one (1) Vida Griddle Cleaning Kit, and one (1) Vida Griddle Breakfast Kit, with a total estimated value of \$1,005.00 CAD (One Thousand Five Canadian Dollars); and
 - (D) From Canadian Tire Shediac, one (1) “Car Cleaning Package” including: one (1) Simoniz 52" Wash Brush, one (1) Simoniz Interior Brush, one (1) Simoniz Detailer Set, one (1) Canadian Tire 5gal Bucket, one (1) Canadian Tire 2gal Bucket, one (1) Simoniz 2300 psi Pressure Washer, one (1) Chemical Guys Foam Cannon, one (1) Silverwax Foam Gum Prep, one (1) Chemical Guys Leather Cleaner, one (1) Simoniz Polisher Kit, one (1) package Simoniz Microfibre Towels, one (1) Simoniz Dirt Trap, one (1) Chemical Guys Glass Cleaner, one (1) Chemical Guys Wheel Cleaner, one (1) Armor All Car Wash Pack, one (1) Simoniz Wash Mitt, one (1) Jumpstart Bucket, one (1) package Armor All Disinfectant Wipes, and one (1) Simoniz Dashboard Protectant, with a total estimated value of \$1,000.00 CAD (One Thousand Canadian Dollars).
- (iv) One (1) gift certificate from Canadian Tire with a total value of \$1,000.00 CAD (One Thousand Canadian Dollars).
 - (v) One (1) Paint and Body Shop Supply Kit from East Coast Fasteners, with a total estimated value of \$2,000.00 CAD (Two Thousand Canadian Dollars).
 - (vi) One (1) set of three (3) Flex Power Tool Kits from East Coast Fasteners, including:
 - (A) Circular Saw, Reciprocating Saw, Angle Grinder and Drill Driver Kit, which includes a 7-1/4" Circular Saw, a 1/2" 2-Speed Drill Driver, a Reciprocating Saw, a 5" Fixed Speed Angle Grinder with Side Switch, a 2.5 Ah Lithium-Ion Battery, a 5.0Ah Lithium-Ion Battery, a 160W Fast Charger, Accessories, and a FLEX Bag;
 - (B) Gear-Driven Orbital Polisher Kit, which includes a Gear-Driven Orbital Polisher, two 5.0Ah lithium batteries, a 160W Fast Charger, a 5 inch backing pad, a 6 inch backing pad, an Allen key, and a Soft Bag; and
 - (C) 1/2" Compact Impact Wrench Stacked Lithium Kit, which includes a 1/2" Compact Size Impact Wrench, a 3.5Ah Stacked Lithium Battery, a 160W Fast Charger, a Belt Clip, and a Soft Bagwith a total estimated value of \$2,200.00 CAD (Two Thousand Two Hundred Canadian Dollars).

- (vii) One (1) Cummins P2500i Inverter Portable Generator from J&D Electric Ltd., with a total estimated value of \$1,155.00 CAD (One Thousand One Hundred and Fifty-Four Canadian Dollars).
 - (viii) One (1) gift certificate from BF Goodrich Tires with a total value of \$1,000.00 CAD (One Thousand Canadian Dollars).
 - (ix) One (1) prize package from Audio Crew and Kicker, containing 6.5” High-Performance Speakers, 6x9” High-Performance Speakers, 5-Channel Amplifier, and Subwoofer in a Custom Enclosure, with a total estimated value of \$1,300.00 CAD (One Thousand Three Hundred Canadian Dollars).
 - (x) One (1) prize package from Audio Crew and Audio Control, containing 6.5” High-Performance Speakers, 6x9” High-Performance Speakers, 5-Channel Amplifier, and Subwoofer in a Custom Enclosure, with a total estimated value of \$1,300.00 CAD (One Thousand Three Hundred Canadian Dollars).
 - (xi) One (1) prize package from Great Hobbies, containing one(1) 2025 NASCAR RC Race Car 1/12 AWD RTR, Ross Chastain Busch #1 and one (1) 2025 NASCAR RC Race Rac 1/12 AWD RTR, Ryan Blaney Advance #12, with a total estimated value of \$498.00 CAD (Four Hundred Ninety-Eight Canadian Dollars).
- (e) There are four (4) **Cash Prizes** from the Contest Organizer, with respective values of:
- (A) \$1,000.00 CAD (One Thousand Canadian Dollars);
 - (B) \$2,000.00 CAD (Two Thousand Canadian Dollars);
 - (C) \$3,500.00 CAD (Three Thousand Five Hundred Canadian Dollars); and
 - (D) \$7,500.00 CAD (Seven Thousand Five Hundred Canadian Dollars).
- (f) There are two (2) **Attendance Prizes**, consisting of:
- (i) One (1) gift certificate for travel from CAA Atlantic, with a value of \$4,000.00 CAD (Four Thousand Canadian Dollars); and
 - (ii) One (1) 25L Chilly Moose Cooler from Orbit Insurance, with a total estimated value of \$300 CAD (Three Hundred Canadian Dollars).
- (g) There are an unknown number of **Daily Prizes** available to be won, consisting of small or promotional items, with an estimated retail value ranging between \$4.00 CAD (Four Canadian Dollars) to \$20.00 CAD (Twenty Canadian Dollars).
- (h) All Contest Prizes are subject to the following conditions:
- (i) any options and/or upgrades on any of the Contest Prizes are the sole responsibility of the Contest Prize winners.
 - (ii) the Contest Prizes must be accepted as awarded, are non-refundable and non-transferable.
 - (iii) accessories and options on the Contest Prizes may vary and are subject to change without notice.

- (iv) the Contest Organizer reserves the right to change the Contest Prizes at any time without incurring any obligations, however, in such an event, the Contest Organizer will make reasonable efforts to provide a prize of equal or greater value.
 - (v) all other costs and expenses not specified herein, if any, are the sole responsibility of the Contest Prize winner.
 - (vi) the approximate retail value of each of the Contest Prizes is an approximation and any difference between the approximate value specified herein and the actual value of the Contest Prize will not be awarded.
- (6) **Odds of Winning.** The odds of winning depend on the number of eligible entries received before the Contest End Date.
- (7) **Skill-Testing Question.** Selected Entrants will be required, as a condition of winning a prize, to correctly answer, without assistance of any kind, the Contest Organizer's time-limited, mathematical skill-testing question to be administered by the Contest Organizer.
- (8) **Grand Prizes Winner Selection.** On July 19, 2026, at 03:00:00 p.m. ADT (UTC -3) at the award stage in Centennial Park, Moncton, New Brunswick, the Contest Organizer, or an employee, agent, or other representative of the Contest Organizer, will conduct a random draw from all eligible entries received before Contest End Date and select the potential winners ("**Selected Entrants**").
 - (a) Selected Entrants will be deemed winners if they meet all of the eligibility criteria set out in these Contest Rules. If a Selected Entrant does not meet the eligibility criteria, they will be disqualified and will not receive a prize and another entrant will be selected by way of a random draw from the remaining eligible entries. Before being declared a winner, Selected Entrants will be required to:
 - (i) correctly answer the Contest Organizer's skill-testing question;
 - (ii) sign and return the Contest Organizer's Declaration of Eligibility and Liability/Publicity Release form ("**Winner Release**"); and
 - (iii) comply with all other Contest Rules, all in the sole discretion of Contest Organizer.
 - (b) There will first be one (1) separate random prize drawn from all eligible entries received for each of the three (3) Show Prizes available to be won. The winning entries will not be re-entered for subsequent Show Prize draws.
 - (c) After all winning entries have been drawn for the Show Prizes, and prior to the drawing of any entry for the Sponsor Prizes, all Show Prizes winning entries will be returned into the draw.
 - (d) There will be one (1) separate random prize drawn from eligible entries received for each of the fourteen (14) Sponsor Prizes available to be won. The winning entries will not be re-entered for subsequent Sponsor Prize draws.

- (e) After all winning entries have been drawn for the Sponsor Prizes, and prior to the drawing of any entry for the Cash Prizes, all Sponsor Prizes winning entries will be returned into the draw.
 - (f) There will then be one (1) separate prize drawn from eligible entries received for each of the four (4) Cash Prizes available to be won. The Cash Prizes will be drawn in order of small to largest prize. The winning entries will not be re-entered for subsequent Cash Prize draws.
 - (g) Odds of being selected depend upon the total number of eligible entries received during the Contest Period. The odds of being selected for one of the Grand Prizes are estimated to be 1 in 2,000. The odds of being selected for the Attendance Prize is estimated to be 1 in 20,000.
 - (h) **The selected entrants for the Grand Prizes must present themselves at the Atlantic Nationals award stage in Centennial Park, Moncton, within three (3) minutes of being declared a selected entrant at the Contest Ceremony.** If a selected entrant for a Contest Prize does not present himself/herself to the Atlantic Nationals award stage within three (3) minutes of being declared a selected entrant, he or she will be automatically disqualified and a new random draw from the remaining eligible entries will be conducted to select another entry and the process noted above will be repeated until a selected entrant presents himself/herself to the Atlantic Nationals award stage to claim their prize or until there are no more eligible entries, whichever comes first.
 - (i) The selected entrant for the Attendance Prize offered by CAA Atlantic may claim his or her prize in accordance with the rules and regulations located at the CAA booth in Centennial Park, Moncton, during the Contest Period.
- (9) **Daily Prizes Winner Selection.** On July 18 and July 19, 2026, from 10:00 a.m. ADT (UTC -3) to 03:00 p.m. ADT (UTC -3), at the Canadian Tire Prize Trailer or similar area, the Contest Organizer, or an employee, agent, or other representative of the Contest Organizer, will conduct a random draw from all eligible entries received before Contest End Date and select the potential winners ("**Selected Daily Prize Entrants**").
- (a) The vehicle number registered to each Selected Daily Prize Entrant will be posted on the Prize Trailer.
 - (b) These numbers may be erased at any time by the Contest Organizer or an employee, agent or other representative of the Contest Organizer, and all numbers will be erased at the end of each show day.
 - (c) Selected Daily Prize Entrants do not have a choice of prize won.
- (10) **Prize Winner Confirmation.** Before being declared a winner of a Contest Prize, a Selected Entrant or Selected Daily Prize Entrant, as the case may be, must first do each of the following, as may be applicable:
- (a) for all Contest Prizes, except for the Attendance Prizes, show proof of registration in the Event for the entire Contest Period;

- (b) for all Contest Prizes, correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question before the prize is released to the winner; and
 - (c) for all Contest Prizes, except the Daily Prizes, sign a Declaration and Release Form, attached hereto as Schedule "A", confirming compliance with these Official Contest Rules and Regulations, acceptance of the Grand Prize, Subsidiary Prize or Attendance Prize as awarded without substitution, and releasing the Contest Organizer, Show Partners, Contest Hosts, and Contest Sponsors, their affiliated and related companies, advertising and promotional agencies, and their respective members, shareholders, directors, officers, employees, agents, representatives, successors and assigns from any liability in connection with the Grand Prizes, Attendance Prizes or the Contest.
 - (d) Failing to comply with any of the requirements of subsection (c) above within three (3) days of being declared a selected entrant, declining a Contest Prize, failing to answer the mathematical skill-testing question correctly, or failing to authorize and/or submit all documentation necessary to complete a confidential background check will cause the Grand Prize, or Attendance Prize, as the case may be, to be forfeited and a new random draw from the remaining eligible entries will be conducted to select another entry and the process noted above will be repeated until a winner is declared or there are no more eligible entries, whichever comes first.
 - (e) The Contest Organizer reserves the right to disqualify a selected entrant from being declared the winner of a Contest Prize if doing so would violate applicable Canadian laws or regulations.
- (11) **No Prize Exchange or Substitution.** Prize Winners must pick up their own Contest Prize, no alternate is permitted. No Contest Prize may be exchanged.
- (12) **Release and Indemnification.** All winners must sign the Contest Organizer's Winner Release to: (1) confirm compliance with all Contest Rules; (2) agree to accept prizes as awarded; (3) release, discharge and hold harmless the Contest Organizer, its departments and agencies, parent, related and affiliated companies, subsidiaries, franchisees, advertising and promotional agencies, counsel, marketing partners, and each of their respective directors, officers, employees, shareholders, successors, Contest Organizers, partners, licensees, subsidiaries, agents, artists, advisors, assignees, and all others associated with the administration, development and execution of the Contest (Released Parties) from any and all manner of action, cause of action, claim or demand, loss or injury, or any suit, debt, covenant, contract, including legal fees and expenses, whatsoever, including but not limited to, claims based on negligence, breach of contract and fundamental breach, failure of any third-party contractor or supplier used in connection with any aspect of the Contest to perform or deliver any goods or services, or any act of God or any other event beyond the Released Parties' control, any dissatisfaction of any kind by a winner with any aspect of the Contest or any prize, liability for physical injury, death, or property damage which the entrants, or guests or other third parties, their heirs, successors or assigns have, might have or could have suffered, by reason of or arising out of the entrant's participation in the Contest and/or in connection with the acceptance and/or exercise by the entrant of prizes as

awarded; and (4) indemnify the Released Parties against any loss, damage or expense, including legal fees, that any of the Released Parties may suffer or incur as a result of any non-compliance by entrants with any of the Contest Rules or participation in the Contest and/or in connection with the acceptance and/or exercise by an entrant, use or misuse of a prize or any travel related thereto.

The Contest Organizer is not responsible for:

- (a) (1) incorrect or inaccurate entry information that may affect a person's ability to participate in the Contest or be awarded a prize, including but not limited to human error, technical malfunctions, lost or delayed entries for any reason, mail failures, omission, or any combination thereof, and entries that fail to fully comply with these Contest Rules;
 - (b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software;
 - (c) lost, incomplete, delayed, mutilated, or misdirected entries or Winner Releases;
 - (d) injury or damage to entrants' computers or to any other individual's computer related to or resulting from participating in, or downloading any material regarding the Contest or accepting a prize;
 - (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use or misuse of any prize, including any related travel and the use of entries by Contest Organizer;
 - (f) the security or privacy of information transmitted via computer networks or for breaches of privacy due to interference by third-party computer hackers or otherwise; or
 - (g) late, lost, misdirected or unsuccessful efforts to notify a potential winner.
- (13) **Other Conditions.** The Contest Organizer reserves the right to terminate or amend this Contest at any time and in any way, without prior notice to entrants. Without limiting the foregoing, if, for any reason, the Contest is not capable of running as originally planned, the Contest Organizer reserves the right to terminate the Contest and conduct a random draw from all previously received eligible entries received by the Contest End Date.
- (14) **Publicity and Entrant Information.** With the exception of any personal information of entrant which is subject to applicable privacy laws and the terms of Contest Organizer's privacy policy, with any participation in the Contest, entrants consent to the use of the entrant's name, social media handle[s], comments and image, or other likeness, whether on videotape or via photograph, for the administration of the Contest or any publicity carried out by the Contest Organizer, (and any co-Contest Organizers) and their respective parent and affiliate companies, and each of their agents and representatives, and marketing partners, without further notice or compensation.

- (15) **Governing Law.** The Contest is void where prohibited by law and is subject to all applicable Canadian federal, provincial, territorial, municipal, and local laws. This Contest shall be governed exclusively by the laws of the province of New Brunswick, including all issues and questions concerning the construction, validity, interpretation and enforceability of these Contest Rules, rights, and obligations between and the Contest Organizer, and procedural provisions, without giving effect to any choice of law or conflict of law rules. Any dispute shall be adjudicated by the courts sitting in Moncton, New Brunswick.
- (16) **Rule Amendments.** The Contest Organizer reserves the right, in its sole discretion, to amend or modify these Contest Rules, or modify, cancel, or suspend this Contest, without prior notice for any reason whatsoever, including without limitation in the event that any cause beyond the reasonable control of the Contest Organizer corrupts, or threatens to corrupt, the security or proper administration of the Contest.
